


DEVELOPING NIGERIA'S ECONOMIC RECOVERY PLAN



Through PDF Bridge's support, the Office of the Vice President developed an economic recovery plan targeted to build resilience in a post-COVID-19 economy. The plan is tagged the 'Nigeria Economic Sustainability Plan' (NESP). This revolves around fostering new ways of working, producing, learning and managing public health and safety in the years to come. This includes building resilience across critical sectors, including aviation, education, healthcare, internal security, mining, water and sanitation. This plan will support vulnerable groups, stimulate local production, prioritize activities in sectors that are job-intensive such as agriculture, power, housing, public works, technology and MSMEs. The Economic Sustainability Committee, an inter-ministerial Committee, will be chaired by Vice-President Yemi Osinbajo and would work with the National Economic Council. The PDF Bridge programme through its Trade Policy Workstream held its first Non-Oil Exporter's dialogue digitally. The theme was 'Addressing Barriers to Foreign Market Access' Participants at the forum observed the urgent need to restructure Nigeria's trade basket to reduce the dominance of crude oil. They also noted that the technology for processing commodities is woefully obsolete and this puts commodities from Nigeria at a comparative disadvantage.
